### **Retainer**

A \$350 retainer will reserve the time and date agreed upon, and Photography by Vince will not make other reservations for that time and date. For this reason all retainers are non-refundable, even if the date of the wedding is changed or the wedding is canceled for any reason. This retainer will be deducted from the price of your wedding package.

### **Image Retouching**

All images on your Master DVD's will be color corrected and toned. This is an exclusive service that Photography by Vince provides. Vince and Lisa deliver on average, 600 to 1000 images per wedding.

All images in albums and portraits are given basic retouching to soften facial blemishes, correct most eyeglass reflections, and remove stray hairs. We take a subtle approach to retouching so it isn't obvious that anything has been done. Additional retouching services are available upon request.

### **Sales Tax**

The state of Virginia requires that professional photographers charge sales tax on all products and service fees. Thus 5% sales tax will be added to the total of any order.

# Wedding Contract

1. It is understood Photography by Vince is the exclusive official photographer retained to perform the photographic services requested on this Contract. In order to eliminate confusion and to insure our results we must insist that we be the exclusive photographer at all times. We allow family and friends to take their own candid photographs at the reception or by approval of the photographer(s).
2. Photography by Vince may substitute another photographer to take the photographs in the event of Studio/Photographer's illness or scheduling conflicts. In the event of such substitution, Studio/Photographer warrants that the photographer taking the photographs shall be a competent professional.
3. The balance of the Contracted Plan is due one week prior to the event. Please add appropriate state sales tax to the contract amount. No part of any order will be delivered until the balance is paid in full.
4. The Studio/Photographer reserves the right to use originals and/or reproductions for advertising, display, publication or other purposes.
5. Upon signature, the Studio/Photographer shall reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason all retainers are non-refundable, even if the date of the wedding is changed or the wedding is canceled for any reason.
6. If the Studio/Photographer cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to the Photographer's illness or emergency, then the Photographer shall return the retainer to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera/computer malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event the Studio/Photographer fails to perform for any other reason, the Studio/Photographer shall not be liable for any amount in excess of the retail value of the Client's order.
7. The charges in this Contract are based on the Studio/Photographer's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed. Packages may change or Products substituted due to availability from vendors.
8. Notice of COPYRIGHT: It is ILLEGAL to copy or reproduce these photographs elsewhere without Studio/Photographer's permission and violators of this Federal Law will be subject to its civil and criminal penalties.
9. This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties.
10. Your previews may be picked up approximately Two weeks after the event. Please call our office to schedule a time to pick up your previews. All consultations and pick-ups are by appointment only.
11. All event orders are to be placed at one time. All family and friend orders are to be prepaid.
- 12. Album design consultations are to be scheduled by the client within three months of wedding date. Any client that has not meet these terms within six months of wedding date, will be charged an additional \$300.00 late fee. The Scheduling of the album design consultation is the client's sole responsibility.**
13. Photography by Vince cannot be held responsible for lack of coverage caused by the bride or wedding party not being ready on time, or by the church or synagogue restrictions regarding photography. Please advise us of any factor that may affect this studio and the photography.
14. For weddings that provide meals for guests we request that you provide meals for the photographers. This will be handled with the up most professionalism and will be done so as not to interrupt the photographic coverage of your wedding day.
